WHO WE ARE

ARDC MISSION STATEMENT

The mission of the ARDC is to promote and protect the integrity of the legal profession, at the direction of the Supreme Court, through attorney registration, education, investigation, prosecution and remedial action.

As an administrative agency of the Supreme Court of Illinois, the ARDC assists the Court in regulating the legal profession through attorney registration, education, investigation, prosecution and remedial action.

Through our annual registration process, we compile a list of lawyers authorized to practice law. We provide ready access to that list so that the public, the profession and courts may access lawyers' credentials and contact information.

We educate lawyers through seminars and publications to help them serve their clients effectively and professionally within the bounds of the rules of conduct adopted by the Court. We provide guidance to lawyers and to the public on ethics issues through our confidential Ethics Inquiry telephone service.

The ARDC handles discipline matters fairly and promptly, balancing the rights of the lawyers involved and the protection of the public, the courts and the legal profession. Grievances are investigated confidentially. Disciplinary prosecutions are adjudicated publicly and result in recommendations to the Court for disposition. Our boards consist of independent, diverse groups of volunteer lawyers and non-lawyers who make recommendations in disciplinary matters.



We advocate for restitution and other remedial action in disciplinary matters. We seek to provide reimbursements through our Client Protection Program to those whose funds have been taken dishonestly by Illinois lawyers who have been disciplined.


87% of lawyers in Illinois practice in six counties

2021 REGULATORY ACTION

INVESTIGATIONS

3,881 grievances against **2,979** lawyers representing **3.1%** of all registered lawyers.

64% of grievances stem from a breakdown in attorney-client relations.

Top 5 allegations

- Neglect (26%)
- Failure to communicate (12%)
- Billing and fee issues (8%)
- Incompetent representation (8%)

Top 5 practice areas

- Criminal law (33%)
- Domestic relations (21%)
- Tort (10%)
- Real estate (9%)
- Probate (9%)

PROSECUTIONS

48 formal disciplinary complaints filed before the Hearing Board

41 disciplinary and regulatory proceedings filed directly with the Illinois Supreme Court

79% of formal disciplinary complaints charged fraudulent or deceptive activity in connection with alleged misrepresentation to clients, a tribunal or others, or the conversion of trust funds

67% of disciplinary proceedings before the Hearing Board were uncontested

49% of disciplinary complaints were concluded by the filing of discipline on consent




DISCIPLINARY SANCTIONS

84 sanctions entered by the Illinois Supreme Court against **83** lawyers


33 sanctions were discipline on consent

35 sanctions were discipline reciprocal to sanctions entered by another jurisdiction

33% of sanctions were either disbarment or suspension until further order of the Court

2,817 calls received from lawyers, providing research assistance and guidance regarding ethics issues and the Illinois Rules of Professional Conduct, free of charge.

2021 REMEDIAL ACTION

CLIENT PROTECTION PROGRAM

\$715,311 in reimbursements on **58** approved claims involving **31** different lawyers

40% of approved claims paid out \$2,500 or less

71% of approved claims involved unearned or unrefunded legal fees

22% arose out of real estate or loan modification matters

94 claims were denied

PROBATION, DEFERRALS AND DIVERSION PROGRAM

183 lawyers monitored for substance or mental illness impairments, law office management issues or restitution conditions

69 Reciprocal probation

45 Suspension pending restitution

21 Probation

22 Supervision/108

17 Diversion

5 Conditional Admission

4 Conditional Reinstatement

62% monitored with substance abuse or mental conditions

25% monitored with law office management conditions

40 lawyers to LAP, accounting for 11% of LAP's referrals.

12 lawyers contacted successfully by intermediaries

29 investigations for possible receivership of a lawyer's law practice
